BWH designed the renovation and expansion of the Anne Arundel Security Center, incorporating a Lobby to enhance security at the building entry. The expansion of the lobby was strategically executed over interior basement space, situated on a plaza area. Despite the building's occupancy during construction, temporary entrances were thoughtfully prepared to ensure seamless accessibility throughout the project duration.

## PRINCE GEORGE'S COUNTY DEPARTMENT OF CORRECTIONS

This project entailed the replacement and expansion of Medical Unit and Mental Health Facilities at the Prince George's County Correctional Center in Upper Marlboro, MD. The new medical unit spans 14,354 square feet, replacing the previous 5,870 square feet area. It features expanded first-floor space incorporating medical and mental health patient areas, with administrative areas housed on a 5,600 square feet second floor. The facility meets federal, state, and local codes, including ADA and Maryland's Green Building Program. It includes 16 male and 8 female mental health isolation cells, open wards, exam rooms, and counseling offices. Centralized officer/nurse stations provide efficient observation. A green living roof is incorporated to aid stormwater management.

## TAKOMA PARK POLICE STATION

We optimized space through interior design services and provided multiple design options for the Takoma Park Police Station. BWH orchestrated upgrades and renovations, featuring reorganization of spaces and the addition of a Mental Health Crisis Response Center. Enhancements at the police station included a dispatch area with ballistic glazing, bullet-resistant wall panels, a bill-paying station, and an interview room.
